# **Perception of Climate Change Information Dissemination Mediums in Ethiopia**

In most developing countries, the dissemination of information about climate change has largely been done by government agencies through mass media. This study examined the sources of climate change information and their reliability in selected cities in Ethiopia. Adopting a survey research design, data on sources and the trustworthiness of climate change information were randomly collected in five Ethiopian cities. The analysis revealed that mass media were the major source of information on climate change. However, with a computed reliability index of 3.08 for all sources of information, the mass media had a low-reliability index of 2.66, compared to faith-based organisations with a 3.50 reliability index. There was apathy towards information from the mass media and government agencies. A high level of trust was ascribed to sources from family and local communities, while religious institutions were perceived to be the most reliable. Therefore, an all-inclusive climate change information dissemination mechanism should be adopted, with the active participation of religious institutions, which have hitherto been left out in climate change discourse in the country.

#### Introduction

Climate change poses an exceptionally complex challenge to humanity. It represents one of the greatest environmental, social, economic and threats facing human political (Intergovernmental Panel on Climate Change (IPCC), 2022). The fourth Assessment Report of the IPCC (2007) dispels many uncertainties about climate change. Warming of the global climate system is explicit and according to IPCC (2007), the observed increase in global temperature since the mid-20th century is triggered by human activities such as increasing rates of fossil fuel burning and land use and land cover changes. As human activities continue unabated, especially in the developing countries' quest for development, climate change impacts will uninterruptedly undermine the achievement of sustainable development (Anukwonke et al., 2022) The outcome of climate change includes droughts, floods and other disasters (United Nations Environment Programme [UNEP], 2008). This may likely deepen the poverty horizon (UN-Habitat,

2011; Odufuwa *et al.*, 2012; Kasim, 2018). For example, in developing countries, the impacts of climate change that have implications on poverty outcomes are manifold. These range from severely longer periods of drought, heavier and increased rainfall variability, flooding and sea level rise to water scarcity among others (Agbola, 2011; Kasim *et al.*, 2020). Climate change has emerged as one of the issues at the forefront of international discourse and dictates how people plan, manage and live in towns and cities.

Climate change impacts everyone regardless of national borders and the impact does not respect developing or developed countries (Ki-moon, 2007). It is important to note that regardless of the anticipated outcomes of climate change, it is the poorer developing nations that are often hit hardest (Prakash, 2008). As observed by Vidal and Radford (2005), one in about six countries globally faces food shortages owing to severe drought that could become more intense under climate change influence. Africa is the greatest concern since many countries within the continent are already stressed

and are in difficulties. Thus, areas prone to drought, such as Ethiopia, will become drier under the effect of climate change. In 2009, the Food and Agriculture Organization (FAO) and the United States government monitored global food challenges and agreed that 34 nations in the continent are experiencing drought and food insecurity. Based on existing indices, more countries could be vulnerable to food shortages in the coming decade (FAO, 2009).

The climate change challenges in Africa provide a compelling need to develop climateresilient strategies to minimize vulnerability and protect the existing infrastructure in environment for sustainable development (UNEP. 2008; African Union, 2022). To this end, a multilateral framework termed the Paris Agreement to manage climate change drivers was adopted at the UN Climate Conference in December 2015. Almost all countries have developed national achievable climate change mitigation targets. The targets can only be achieved if there are transparent monitoring mechanisms and appropriate information dissemination strategies are adopted to ensure that the adopted developmental projections are in sync with the universally agreed pathway of reducing global warming to less than 2°C. At present, climate change is real and its impact does not differentiate individuals based on race, socioeconomic status, cultural, political and religious leaning. Therefore, effective climate changerelated planning actions and strategies should be driven and depend on the community's capacity to mitigate and adapt to climate change. This will only be possible by reorganizing community structure in line with evolving challenges as reported by information communication agencies. Information about innovation, especially on climate change issues, in Africa has been conventionally originating and associated with formal organisations (Heeks et al., 2013; African Development Bank Group, 2023). This is necessary but not sufficient because the capacity and desire to accommodate and adopt innovational change depend on the reliability of the information sources. Therefore, this study was designed to provide insights into the effectiveness of climate change communication strategies and to identify potential areas for improvement to increase public engagement and understanding of the issue.

### Literature review

The 1995 World Summit for Social Development, held in Copenhagen, established the concept of integration for inclusive society. The summit conceptualizes social inclusion as an overarching goal with a multi-dimensional process that is critical to the promotion of sustainable human development. Sustainable development inclusiveness are conjoined and can serve as an enabler in the attainment of desired structural transformation, increased prosperity and peaceful co-existence (UN-Habitat, 2015). However, global warming, climate change and poverty have been identified as one of the major challenges to development. is sustainable This compounded by rapid urbanization and land use and land cover change, in most developing countries. Climate change has been documented as a principal factor undermining Africa's pathways to sustainable development (Agbola, 2011; UN-Habitat. 2015; Ayinu et al., 2022). There is a demand and call to develop all-inclusive strategies to mitigate and adapt to climate change impacts. The strategies should also involve sustainable use of resources and protection of environmental common properties against the negative reactions and consequences of climate change ((Hiremath et al., 2013; Moreno Pires et al., 2014; Science for Environment Policy, 2015; Agbola and Kasim, 2019). The inclusive strategies, including the information dissemination process, will allow all community sectors to contribute to, and participate in, the developmental process collectively and equally, regardless of individuals' position and circumstances community in the (Asia Development Bank, 2011).

Globally, information and societies are conjoined (Nwagwu, 2006). The key to successful community engagement for inclusive development is hinged on efficient information gathering, processing and dissemination. In achieving a consensus on the sustainability and uptake of research outputs, information about the research must be adequately and inclusively disseminated. Dissemination is a range of activities designed to make project outputs available to persons not directly involved in a project. Therefore, in assessing the extent to which information dissemination efforts meet the goals and objectives of a programme, the disseminators need to develop performance criteria and measures of effectiveness

for the information disseminated. Performance criteria of any information can be assessed using three different but interrelated dimensions. These are the credibility of information, market penetration and the receiver's (individual's) information. response to the Information dissemination medium will be adjudged credible if it is accepted, utilized and has an expected impact on operations. Market penetration refers to the percentage of the potential audience reached by the information disseminated. Ultimately, the purpose of providing the information is to effect some changes in behaviour that will cause an improvement in, for example, human-environment interactions at an individual scale (Wenjing, 2011; Heeks et al., 2013; Foster and Heeks, 2013).

Individuals acquire or require information for different reasons. The reason may include the need to learn about certain diseases, avoid potential danger and understand emergency preparedness arrangements (Wenjing, 2011). However, the critical questions associated with information dissemination processes are: what are you disseminating and who is the target audience? What is the reason for disseminating the information and what is the medium for disseminating it? What is the procedure to be adopted in engaging with the target audience throughout the process? Are there mechanisms in place for reflection, monitoring, evaluation and re-planning? How do you measure the success of information disseminated to the target audience? (King, 2003; Southwell et al., 2005). In answering these questions, King (2003) observes that information disseminated by any means is primarily designed to achieve all or any of the following: create awareness, educate individuals and increase knowledge for action in meeting individuals' needs. To achieve the objective of information dissemination as observed by King (2003) and Wenjing (2011), the required information by individuals and society can be disseminated using different channels such as public engagement, mass media, social media, policy briefs, handbills, and person-to-person among other. For capacity building development at an individual level, sources for information can be from a plethora of channels (Kaplinsky, 2011). Information disseminated using different (government, private social/informal) channels. These channels of

information dissemination have shown different levels of success and limitations based on credibility, market penetration and receivers' response to the channel of propagating the information (Wenjing, 2011; Pew Research Center, 2018). Unfortunately, for most of the human population, obtaining accurate and reliable information in the correct format at the right time may be difficult (Kaplinsky, 2011).

To address the limitations associated with existing information dissemination mediums, there is a need to develop alternative mechanisms for disseminating reliable information accurately to people in a reasonable time frame. In recent times, there has been an extension in the information dissemination process, incorporating alternative mechanisms with the active involvement of the private sector and non-governmental organisations such as Faith-Based Organizations (FBO) and Community-Based Organizations (CBO) as major partners for development (Marshall and Saanen, 2007; Farquharson et al., 2011; Lyons, 2015; Swart and Nell, 2016; Chowdhury et al., 2019). Therefore, involvement and collaboration with trusted civil society organizations and FBOs will help to restore the trust and confidence of citizens in the formal state programme intervention and research outputs on climate change. This collaboration will also aid the process of integration between formal and informal structures in climate change discourse (Olowu, 1999; Musick et al., 2000; Alex-Assensoh and Assensoh, 2001; Wallace et al., 2004).

In contemporary African societies, applicable to many developing countries, religion is one of the most potent and rapidly growing institutions (Erlich, 2010; Abbink, 2011; Vaughan, 2016; Girma, 2018; Pew Research Center, 2018; Paul-Choudhury, 2019). Established Christian denominations and the Pentecostal movement are growing and have been substantially indigenized (Meyer, 1998). Religion plays an important role in spiritual and social development in Africa (Erlich, 2010; Abbink, 2011; Girma, 2018). However, in most countries, there is no formal and sustained engagement between these organisations and national governments on shared roles for community governance and policy implementation (Gifford, 1994; Erlich, 2010; Tilson, 2011; Karbo, 2013; Girma, 2018). It is important to note that

religious non-governmental organisations possess resources that can be tapped. One of the resources that religious organisations can bring to local-level development is trust and greater accountability for information credibility, market penetration and the receiver's acceptability of information for action and implementation.

Methodology

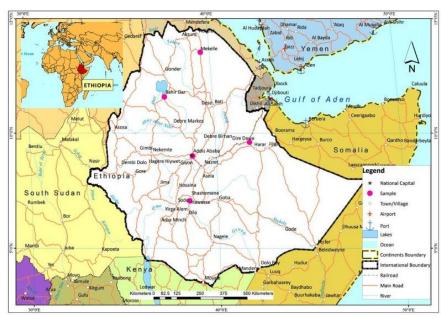


Figure 1: Study locations (Cities) in political map of Ethiopia context

A survey research design was adopted for the study. Five major cities, Addis Ababa, Dire Dawa, Hawassa, Makelle and Bahir Dar, representing the regional primate and charter cities in the central, eastern, southern, northern and western parts of the country, respectively, were purposively selected as shown in Figure 1. The last National Population and Housing Census for Ethiopia was conducted in 2007. The data is outdated and may not account for key groups or areas (United Nations Population Fund (UNFPA), 2019; Qader et al., 2021). Therefore, Google Earth<sup>TM</sup> imageries of the cities were obtained to aid in the delineation of the sample area for the study. Owing to the aerial expansion of Addis Ababa, four out of the existing 10 sub-cities were selected randomly to represent the city, as shown in Table 1. A 3x3 grid lines were imposed on the settlements' Google Earth imageries to delineate them into quadrats. All the quadrats were numbered and a random sampling technique was used to select the required quadrats. From each of

the quadrats selected, the number of residential buildings was counted and validated by groundtruthing.

A random sampling technique was used to select the sample size from the residential buildings in the selected quadrats. A structured questionnaire was administered to a household head per residential building. The designed questionnaire was revised by subject experts and validated by a pilot survey before administration. To determine if the questionnaire is capturing the information it is intended to measure in line with the goals and objectives of the study as noted by de Jong (2018) and Aithal and Aithal (2020), the pre-test of the data collection tools and questionnaire administration should be undertaken. This was done in the major settlements around the selected locations. The pilot studies were carried out on 15 persons each at Adama (Addis Ababa), Gondar (Bahir Dar), Adigrat (Mekelle), Shashemene (Hawassa) and Harar (Dire Dawa). This enabled the testing of the instruments and the level of acceptance by the respondents. The incorporation of the response from the pilot studies improved the feasibility of the study procedure and data collection process. Owing to the language barrier, the questionnaire was converted from the English language to Amharic, the official language of Ethiopia and Tygrigna, the local language in Mekelle, the northern part of the country. The questionnaire was administered in Addis Ababa, Hawassa, Dire Dawa and Bahir Dar using the Amharic language while the questionnaire for Makelle was administered using the Tygrigna language. A set of 1,067 copies of the questionnaire (10.0% of the sample frame) were administered to respondents. From the 1067 copies of the questionnaire administered, 1033, representing 96.8%, were duly completed for analysis that are presented in the form of frequency counts, percentages and table summaries.

To assess the extent to which information dissemination channels could be reliable and effectively inclusive, a set of performance criteria and measures of reliability about these efforts were developed. The reliability of the information sources on climate change in Ethiopia was determined using a 3-point Likert scale. The aggregated weighted mean index was used in analysing data using the 3-point Likert scale to evolve the residents' Reliability Index (RI). The Reliability Index was determined using the ratings "Very Reliable", "Reliable", and "Not Reliable" with assigned weights of 3, 2 and 1, respectively. The Reliability Weighted Value (RWV) for each item in the scales was obtained as the product of the number of responses for each rating to a variable and the respective weight of the value. The RI is obtained by dividing the reliability-weighted value of each score by the total number of respondents. This is expressed as follows:

The total of the Reliability Weighted Value (RWV) for each variable was obtained by summing the product of the number of responses of each rating for a variable and the respective weight of the value. The total of the Reliability Weighted Value (RWV) for each variable was divided by the number of respondents to compute the reliability index as follows:

Where  $n_1$ ,  $n_2$  and  $n_3$  = number of respondents for not reliable, reliable and very reliable, respectively

The Mean Reliability Index (MRI) is computed as the average of the Reliability Index (RI) for a given dataset. This is determined by the summation of the Reliability Index for each item in the set and then dividing by the total number of items (Ni) as follows:

The Mean Reliability Deviation (MRD) is calculated by subtracting the individual RI from the MRI. Any value higher than the average obtained is considered to be reliable. This is obtained as follows:

#### Results

Socio-economic indices (profiles) of the respondents considered were age, gender, educational qualification, occupation and income. Table 2 reveals that 52.4% of the respondents were females. The age classifications show that 15.4% of the respondents were less than 30 years old and 33.6% were aged 50 and above. Ethiopia is a religious country dominated by Orthodox Christians. From the analysis, the majority of the respondents (65.8%) in the cities were Orthodox Christians, 15.0% were Protestant Christians, 14.43% were Muslim, 4.3% were Catholic Christians and 0.5% belonged to other categories (mainly traditional religions and atheist). The Ethiopian Orthodox Church, having served as the official religion of the ruling elite until the end of the monarchy in 1974, has played a dominant role in the culture and politics of the country. Ethiopian political structure is influenced by ecclesiastic traditions (Girma, 2018). For centuries, religion has been central to everyday life in the country. Priests, wearing colourful robes and carrying ornate crosses, are frequently kissed by the people and the Christian faithful genuflect at the sighting of churches' domes. References to God abound in Ethiopian languages and the public

holidays in the country are largely determined by religion. The core area of Christianity is in the highlands of northern Ethiopia but its influence is felt in the entire country. Over 40 per cent of Ethiopians abide by the teachings of the Ethiopian Orthodox Church. About 20% of the citizens adhere to other Christian faiths, specifically, evangelical Christians. Islam is practised by about one-third of Ethiopians.

Distribution in terms of educational attainment revealed that 10.7% were illiterates. 17.1% could read and write, 18.9% obtained primary/adult education certificates, 25.3% had secondary/high school certificates and 28.0% had obtained post-secondary school education certificates. This structure of educational attainment shows that the literacy level of the respondents is high and the majority of those interviewed had adequate knowledge to comprehend the focus of the study. Employment/occupation structure, to a larger extent, is a function of educational attainments. Therefore, the education profile presupposed that the majority of the respondents would be employed. However, from Table 2, 25.18% of the respondents were unemployed and 28.9% were engaged in trading and business activities; 10.7% were artisans, 5.8% were urban farmers, 27.4% were civil servants and 2.0 were professionals. The monthly income of the respondents revealed that the majority (54.2%) earned less than Ethiopian Birr (ETB)3,000, 33.4% earned between ETB3,000 ETB6,000 per month and 12.4% earned above ETB6,000 monthly (Table 2).

The perception of the respondents on the major environmental issues in Ethiopia is presented in Table 3. From the responses, the most prominent environmental issue identified by the respondents was pollution (air and water) (25.5%). Minor environmental issues identified in descending order are: increasing temperature (18.0%), population increase and urban expansion (14.7%), waste disposal and management (12.8%), transportation issues (12.1%), flooding (8.3%), deforestation (5.3%) and resources depletion (3.3%). Perceptions of the respondents on drivers of climate change in Ethiopian cities in descending order are deforestation (29.6%), air pollution (19.5%), transportation activities (15.5%),industrial

activities (14.1%), increasing population and urban expansion (10.4%), urban concretization (land use and land cover change) (7.3%) and agricultural activities (3.6%).

The results of the perception of Ethiopian residents regarding climate as shown in Table 3 revealed that 92.8% of the respondents believed that the country was experiencing climate change. Among them, 66.1% associated climate change with an increase in temperature, while 26.8% perceived it in terms of changing intensity of rainfall, pattern, and flooding. Moreover, 73.8% of the respondents confirmed that Ethiopian cities were experiencing an increase in temperature, and 77.2% believed that the level and intensity of

rainfall and flooding were also increasing due to the climate change phenomenon. However, the respondents appeared to give little attention to the problem of deforestation and agricultural practices, although Ethiopia is an agrarian nation, and about 85% of the population depends on agriculture. It is worth noting that the largest carbon emission of the country is from the agricultural sector, particularly

the livestock sector (Gebremichael *et al.*, 2014). The study, also, revealed that urban expansion and concentration could lead to urban pollution and encroachment to peri-urban areas and urban land use/cover changes. This issue is particularly relevant in the cities of Dire Dawa and Bahir Dar, which are relatively warm compared to other locations in the country.

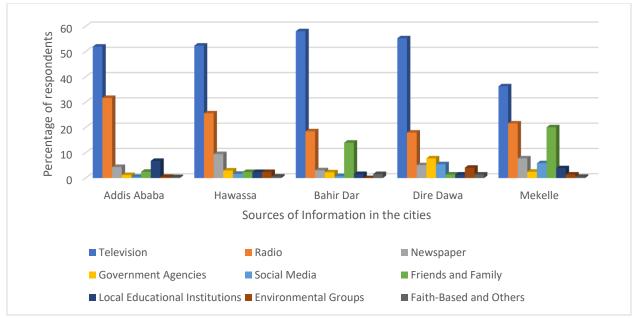


Figure 2: The sources of information about climate change

As shown in Figure 2, 82.1% of respondents obtain their information on climate change from mass media, with television being the most common source (50.7%), followed by radio (25.6%) and newspapers (5.8%). The remaining 17.9% get their information from other sources, including 6.1% from friends and family, 4.3% from local educational institutions, 2.9% from government agencies, 2.4% from social media, 1.5% from environmental groups, and 0.7% from faith-based organisations and informal discussions. Interestingly, respondents in Mekelle showed a different pattern compared to the rest of the cities, such as cosmopolitan Addis Ababa. They reported

the mass media as their primary source of information on climate change. This could be because the information is mostly disseminated in the local language, Tigrigna, which is preferred in the region. Additionally, the Tigray People's Liberation Front (TPLF) has had a strong influence on the federal government in the region, and the people of Tigray tend to be pro-government, particularly in terms of regional government. Therefore, the government-controlled entity may be a more viable medium for disseminating information on a phenomenon in the region than other regions of the country.

Table 4 presents the reliability of sources of information about climate change in Ethiopia. The Reliability Index (RI) was used to determine the reliability of each source, including all the sources combined. The mean RI for sources of information on climate change in Ethiopian cities is 3.076. Among all the sources, faith-based organisations (FBO) had the highest RI of 3.509. The remaining sources ranked in descending order based on their RI, with social media (3.278), local environmental groups (3.262), family and friends (3.146), and educational institutions (3.136). These rankings indicate that faith-based organisations were perceived as the most reliable sources of climate change information in Ethiopian cities. Conversely, government agencies and conventional media had lower RI values of 2.536 and 2.660, respectively, and were considered less reliable sources of information on climate change.

The perceived reliability of different sources of climate change information in different cities of Ethiopia is provided as follows. In Addis Ababa, the mean RI value for all sources of information on climate change was 3.199, which is above average. However, family and friends (3.137RI), media (2.449RI), and government agencies (2.342RI) were perceived to be less reliable than other sources. In Makelle City, the mean RI value was 3.373. Family

members (3.741RI), faith-based organisations (3.630RI), and the media (3.583RI) were considered to be the most reliable sources of information on climate change. However, sources such as educational institutions (3.296RI), government agencies (3.231RI), scientists and environmental groups (3.139RI), and local communities (2.991RI) were perceived to be less reliable. In Bahir Dar, Hawassa, and Dire Dawa, family and friends and faith-based organisations were considered to be the most reliable sources of information on climate change, except for Hawassa where a local community was deemed to be the most reliable source with a mean RI value of 3.315. The study suggests that it is important to use a range of sources to improve the perception of climate change information, as people tend to have a poor perception of mass media as a reliable source.

## **Discussion**

The study evaluated sources of information on climate change and the reliability of the sources to aid the uptake of research on climate change in Ethiopia. Respondents for the study were selected from five cities in Ethiopia. The socio-economic indices indicated that about 90.0% of the respondents were literate and old enough to evaluate climate trends in the country. The income accruing to the respondents generally in Ethiopia is

low. This could hardly support the daily needs of the majority of the respondents bearing in mind the high cost of living in the major cities. This could harm environmental management and resource utilisation. The capacity to cope with climate change-induced disasters could also be compromised leading to increasing poverty and vulnerability to environmental challenges (Gebremichael *et al.*, 2014; Ayinu *et al.*, 2022)

Ethiopia, like other countries in sub-Saharan Africa, is vulnerable to climate change and its associated effects (Harris et al., 2020; Ayanlade et al., 2022; Ayinu et al., 2022). The environmental and social issues identified in the study included pollution (air and water), increasing temperature, population increase and urban expansion, waste collection, transportation issues, flooding, deforestation and resource depletion. These issues have been documented in the literature to have implications on or for climate change either as drivers or outcomes. For example, air pollution and other environmental issues are usually generated locally but with international implications on climate change as a result of the concatenation of the global atmosphere (Ramanathan and Feng 2009; Kasim et al., 2018). Human activities as noted by Etyemezian et al. (2005) have contributed significantly to air pollution owing largely to fossil fuel consumption. In addition to this, poor land use planning, weak capacity to monitor air quality and insufficient pollution control measures have consequences for local meteorological parameters on the one hand and will subsequent, on the other hand, feedback on global climate change (Kasim et al., 2018).

As noted by Beatley (2009), managing climate change and its impact is a function of the coping of communities. depends capacity This significantly on existing local community institutions and social networks (Aldrich, 2012). Mitigation and adaptation strategies are usually strengthened by using the community's knowledge of climate change impacts; improved social and economic trends; community norms and values systems; positive and healthy partnerships among formal actors and social groups and organisations; and strong social communication infrastructures. Several researches have been done in Africa on climate change and its impacts on sustainable development. Also, over the years, in developing countries, a lot of resources have been deployed to propagate information on climate change and its associated impacts, using a variety of mediums. As indicated in this study, about 85.0% of the sources climate change information were from government establishments. The state controls most broadcasting outlets and there is a state monopoly on the telecommunication system in Ethiopia. Access to the internet and mobile telephone services have been constrained in the country during incidences of social unrest (Grinberg, 2017; Hernández and Anthonio, 2022). As observed by Heeks et al. (2013), the reliability level of information produced and disseminated using a centralized government system is always low and this validates the finding of this study. With the primary involvement and control of the Ethiopian government in the information dissemination structure, the citizens generally have apathy towards information emanating from government institutions such as the mass media. The long period of government control and high handedness, on the critical issue of development including and, especially human rights, may be part of the reasons why citizens are skeptical of information from the public information dissemination apparatus.

To change the general perception that people have about a phenomenon, information about the issue and the reliability of the source of information are important. Therefore, it is important to evolve an all-inclusive strategy to disseminate information about climate change and its impact. For example, in public relations research, religion is a relatively unexplored territory for inclusive development which can be used to influence public opinion about global issues, such as climate change (Clarke, 2010; 2013). Religion and family are central to society, especially in religious-conscious countries such as Ethiopia. As observed in the study, the family, local community, environmental group and educational institution had a higher RI value than the mean RI for the study. However, the major source of information on climate change as captured in the study is the media. This outcome presents a paradox where the major source of information on climate change is from the media and it is the least reliable. This can only be explained as emanating from a deep distrust of government-controlled media houses as agents of propaganda (Yetnayet, 2010; Gedion, 2010).

All the identified dissemination agents cannot be divorced from the family and religion. For instance, the family is the bedrock of religious institutions and information from the religious organisations is mostly disseminated through the family. However, with the larger influence of religious institutions as an agent of ecclesiastical and emotional change, studies have regularly recognized the role of religion as a facilitator of

citizen participation in political activities, community engagement, environmental action, volunteerism, social-organisational membership and other behaviours through which society seeks power control. exert and influence developmental agenda (Alex-Assensoh Assensoh, 2001; Musick et al., 2000; Wallace et al., 2004; Pew Research Center, 2012; 2018; Paul-Choudhury, 2019). Faith-based organisations have been taken for granted in the developmental agenda, largely due to their proselytization attributes (Heist and Cnaan, 2016). The share number of persons who identify with religious groups is about 84% of the global population (Pew Research Center, 2012), therefore, there is a need to engage the untapped population resource at the disposal of religious institutions in Africa for sustainable development.

A survey by Pew Research Center (2018) indicates that the share of persons in sub-Saharan Africa who consider religion to be very important in daily lives is very high, ranging from a high of 98% in Ethiopia to a low of 71% in Botswana with a regional average of 89%. A holistic view of FBO activities shows that, like other organisations, FBO is designed to improve the living conditions in the communities where they are located using mores, teachings and generally acceptable injunctions (Rakodi, 2012; Gifford, 2015; Heist and Cnaan, Therefore, information dissemination strategy should incorporate the role that faith plays in transforming customs, norms, and other behavioural aspects of humans to expected dictates in mitigating and adapting to climate change (Mueller, 2004; Tilson and Venkateswaran, 2004; Tilson, 2011).

In addressing the need for action in climate change mitigation and or adaptation, King (2003), using a farming process analogy, identifies three possible phases and purposes of dissemination. The first phase is termed 'scattering abroad' by sowing the seed. This phase primarily refers to the propagation of information about an innovation (climate change) through publishing and reporting of research findings, twitting, blogging, emails and websites. In this study, 'scattering abroad' is satisfied by the media houses based on their reliability index. The second phase is termed 'sowing'. This involves explicitly guiding the scattering of the information, for example, on climate change in a more targeted manner to the

audience. This is satisfied by the government agencies, educational institutions, environmental groups and the family. The final phase is called 'propagating, breeding or growing, reproducing and nurturing' the growth of the seed planted in a precise location. This entails the adoption and or use of an innovative strategy piggy-backed on an existing working entity such as FBO to nurture the uptake of the sowing as indicated by its reliability index in this study.

For example, throughout the history of Ethiopia, religion has played significant roles in the socio-economic and political development of the country (Erlich, 2010; Abbink, 2011; Girma, 2018). As documented in the literature, religious institutions in Ethiopia are venerated and the utterance of priests carries a lot of respect and weight (Erlich, 2010; Karbo, 2013). This is the role this study is advocating for, the hitherto neglected, FBO in the quest to translate information on climate change into action and reality. In performing this role, Shoenberg (2001) likens FBO to the grafting strategy where buds and branches of information are attached to strong rootstock for effectiveness and sustainability. As shown in this research, the sources of information on climate change, in Ethiopia, can be strengthened with the inclusion of FBO as a medium for disseminating information. For example, the media and communication experts can collaborate with FBO to design climate changespecific mitigation or adaptation strategies that focus on tree planting; waste management; water, sanitation and hygiene (WASH); and holistic environmental management. As noted by Olowu (1999), most public relations programmes are yet to fully integrate religious institutions as stakeholders in discussion and or research communication. Therefore, communication professionals, whether educators or practitioners, should foster religious dialogue and mutual understanding of the working of FBOs as agents of change in climate change issues (Tilson, 2011).

#### Conclusion

Climate change is a global problem that has local impacts and drivers. Ethiopia, a country in Africa, is vulnerable to the effects of climate change, while also contributing to greenhouse gas emissions. The consequences of climate change can reverse the progress Ethiopia has made in development. Consequently, it is crucial to have a comprehensive

approach to educating everyone in the country about climate change, its causes, and solutions. This requires collective action aimed at reducing greenhouse gas emissions, minimizing` exposure to climate change impacts, protecting people, and reducing their vulnerability to climate shocks. Climate change is a global issue that affects everyone, regardless of race, gender, religion, or political affiliation. In Ethiopia, religious institutions play a significant role in the country's political and social landscape, making them valuable partners in raising awareness about climate change and promoting strategies to adapt and mitigate its effects. Reliable information dissemination on climate change is essential for the sustainability of mitigation and adaptation strategies in Ethiopia. Faith-based organisations (FBOs) offer a platform to propagate information on climate change impacts and drivers in Ethiopia. However, concerns such as proselytization and member focus need to be addressed. Despite these concerns, FBOs play a critical role in achieving the development and uptake of research outcomes. Thus, in Ethiopia, with its strong religious attachment, the involvement of FBOs in climate change discourse and information dissemination is crucial. Future research should be carried out on the appropriate mechanisms to incorporate climate change-related activities into religious discourse to achieve effective results and an all-inclusive climate change information mechanism.
